Tax features

Tax exemption

Available if your way to work is more than 40 km one way or if you have a severe disability.

Marital status

Religion (church membership)

Members of the Roman Catholic Church or the Protestant Church pay church tax, which is taken directly from the salary and passed on to the respective Church organization. The information about religious affiliation is voluntary and is noted down during the registration at the city hall.

Child tax credit

Guarantees that a certain amount of your income is not taxed but available as living expenses for your child(ren).

Tax bracket

Depends on your marital status and/or on your spouse's tax bracket. Bracket I is for single persons, brackets III/IV/V are available for married persons. Bracket VI should be avoided.

Payment fraction

100% means that you are employed full-time, which is 40.5 hours/week. For example, 75% means that you are employed part-time – 30 hours/

The tax id number is given to you after the first registration of residence in Germany (or after birth) and is for life. Not to be confused with the tax number, which is given by the local tax office when you hand in your first tax declaration.
